International Protection of Investments

This book outlines the protection standards typically contained in international investment agreements as they are actually applied and interpreted by investment tribunals. It thus provides a basis for analysis, criticism, and stocktaking of the existing system of investment arbitration. It covers all main protection standards, such as expropriation, fair and equitable treatment, full protection and security, the non-discrimination standards of national treatment and MFN, the prohibition of unreasonable and discriminatory measures, umbrella clauses and transfer guarantees. These standards are covered in separate chapters providing an overview of textual variations, explaining the origin of the standards and analysing the main conceptual issues as developed by investment tribunals. Relevant cases with quotations that illustrate how tribunals have relied upon the standards are presented in depth. An extensive bibliography guides the reader to more specific aspects of each investment standard permitting the book's use as a commentary of the main investment protection standards.

AUGUST REINISCH is a professor of international and European law at the University of Vienna. He is a Member of the International Law Commission, a membre associé of the Institut de droit international and President of the Austrian Branch of the International Law Association. Professor Reinisch has served as arbitrator in investment cases mostly under ICSID and UNCITRAL Rules. He is a Member of the ICSID Panels of Conciliators and of Arbitrators and of the Court of the PCA.

CHRISTOPH SCHREUER was a professor of International Law at Salzburg University, The Johns Hopkins University and the University of Vienna. He has served as arbitrator in investment cases mostly under the ICSID and UNCITRAL Rules. He is a member of the ICSID Panels of Conciliators and of Arbitrators. He is the author of numerous books and articles in the field of international investment law.

PREFACE

The aim of this book is to describe and explain the investment protection standards typically contained in international investment agreements (IIAs) as applied by investment tribunals. It will provide a basis for analysis, criticism and argument. In this book we do not offer our own views on how investment standards should be interpreted. Rather, we have collected, analysed and systematized the sometimes heterogeneous, if not contradictory, interpretations reached by various investment tribunals. Thus, this book permits a stocktaking of how tribunals have addressed arguments and interests of parties and stakeholders in the area of investment arbitration. It is neither a critique of nor an apology for the existing system.

Conspicuous features of tribunal practice are the inconsistencies and contradictions encountered when interpreting key issues such as the scope of most-favoured-nation (MFN) clauses, the elements of fair and equitable treatment (FET), of umbrella clauses, the defining point of indirect expropriation. At the same time, practice shows the harmonious interpretation of many other elements of the main investment protection standards.

The absence of a fully consistent practice is due, at least in part, to a multitude of bilateral investment treaties (BITs) and a few multilateral agreements with investment chapters which reflect these standards with some variation. In addition, we are dealing with decisions of a wide variety of mostly ad hoc arbitral tribunals deciding specific cases.

Our aim has been to analyse these arbitral interpretations of different treaties by focusing and concentrating on common underlying concepts expressed in often varying language. This approach explains the structure of the book.

We have concentrated on the main protection standards contained in IIAs: expropriation, FET, full protection and security, the non-discrimination standards of national treatment and MFN, the prohibition of unreasonable and discriminatory measures, umbrella clauses and transfer guarantees.

Each chapter provides an overview of the variations of language employed by treaty-makers while stressing the common core of the respective standard. It explains the origin of the standard and analyses the main conceptual issues, focusing on the way tribunals have interpreted them. Each chapter discusses the

relevant cases with quotations that illustrate how tribunals have actually addressed the standard. An extensive, though not exhaustive, bibliography should guide the reader to more specific aspects of the investment standards discussed in this book. These features explain the book's resemblance to a commentary on the main investment protection standards.

The growing case-law in the field and the fact that some decisions and awards remain confidential makes an exhaustive treatment impossible. We have strived to keep the chapters current as of the end of 2018.

This book was made possible by the generous support of the Austrian Science Fund which has funded research projects of Professor Reinisch on the interpretation and application of international investment law. Research and project assistants at the University of Vienna have made valuable contributions to this book: in particular, Christina Knahr, Lukas Stifter, Aima Samatova, Jose Magnaye, Florentina Simlinger, Céline Braumann, Sara Mansour Fallah and Johannes Tropper. The University of Vienna has granted a sabbatical to Professor Reinisch, enabling him to finalize large parts of the manuscript during summer term of 2018.
